The nominations and <u>vacancy</u> election process for **PEF DIVISION** #<u>262</u> will be held under the standard operating procedures of the New York State Public Employees Federation. There are presently (1) position available:

A PEF member may sign only one (1)-nominating petition for their Steward constituency. A nominee may not sign his/her own petition.

Elections will be held only in those constituencies, which have more nominees than open positions. Elections shall be conducted by mail by the Divisions Elections Department. A double envelope system shall be used.

Ballots will be mailed by January 10th, 2025 to be returned by February 3rd, 2025.

Any complaints concerning the fairness of these elections, which are not resolved by the Election Committee, should be brought to the attention of your Regional Coordinator.
