

### DIVISION 234 – OTDA/OCFS 2024 SCHOLARSHIP AWARDS

PEF Division 234 will award eight (8) college scholarships of \$500 each (totaling \$4,000) to the children of PEF Division 234 members who are undergraduate, graduate, or vocational degree candidates during the Fall 2024 semester.

To ensure applicants have an equal opportunity to benefit from our awards program, qualified applicants will participate in a random drawing to receive a scholarship award. A dependent can only win this award once. **Past awardees are not eligible.** To qualify, applicants must send required documentation described below. The information will be verified by the PEF Division 234 Scholarship Committee.

#### **ELIGIBILITY:**

- 1. Applicants must be the child/ren, stepchild/ren, or legal dependents of an active PEF Division 234 (OTDA/OCFS) member as of July 31, 2024.
- 2. Applicants must be enrolled full/part-time at a college, trade, or graduate school for the Fall 2024 semester.
- 3. Applicants must submit Fall 2024 enrollment verification consisting of **one** of the following: a) Fall 2024 class schedule, b) college acceptance letter, c) tuition statement, or d) other form of verification from the applicant's educational institution indicating enrollment for the Fall 2024 semester. *Scholarship applications submitted but lacking the required documentation to verify enrollment will be disqualified.*

#### HOW TO APPLY:

- 1. Complete all sections of the 2024 APPLICATION FOR PEF DIVISION 234 SCHOLARSHIPS.
- 2. Return the application with all required documentation, BY MAIL, to the Scholarship Committee.

#### Applications must be postmarked by Wednesday, July 31, 2024.

Applications postmarked after this date will not be considered.
